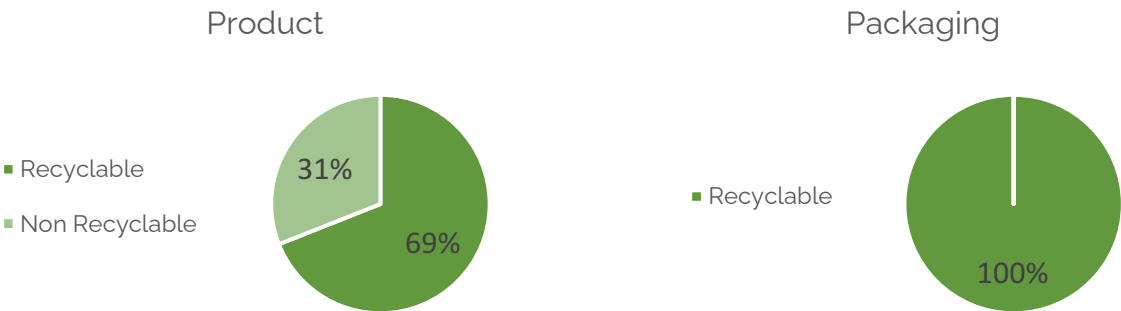

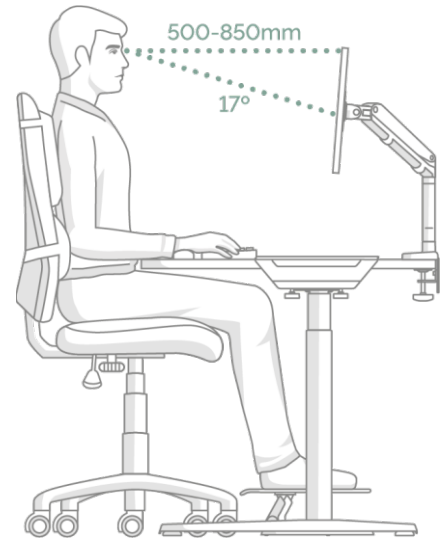


### ZONE 3 RELIEVE NECK STRAIN

the top of your screen.

#### How to use a monitor arm

- 1. Arms Reach:** Whether sitting or standing check that your monitor is positioned so you can touch the screen with your fingertips and that you can easily read what is on your screen without straining.
- 2. Eye level:** Adjust the monitor arm until the top of your monitor/s are roughly level with your eyes.
- 3. Tilt:** Tilting the screen slightly upwards can help achieve a more neutral posture and reduce glare.
- 4. Multiple screens:** If you're using more than one monitor make sure:
  - The tops of each screen are level and positioned side by side;
  - You sit in the middle or in front of your main screen to reduce twisting and turning.

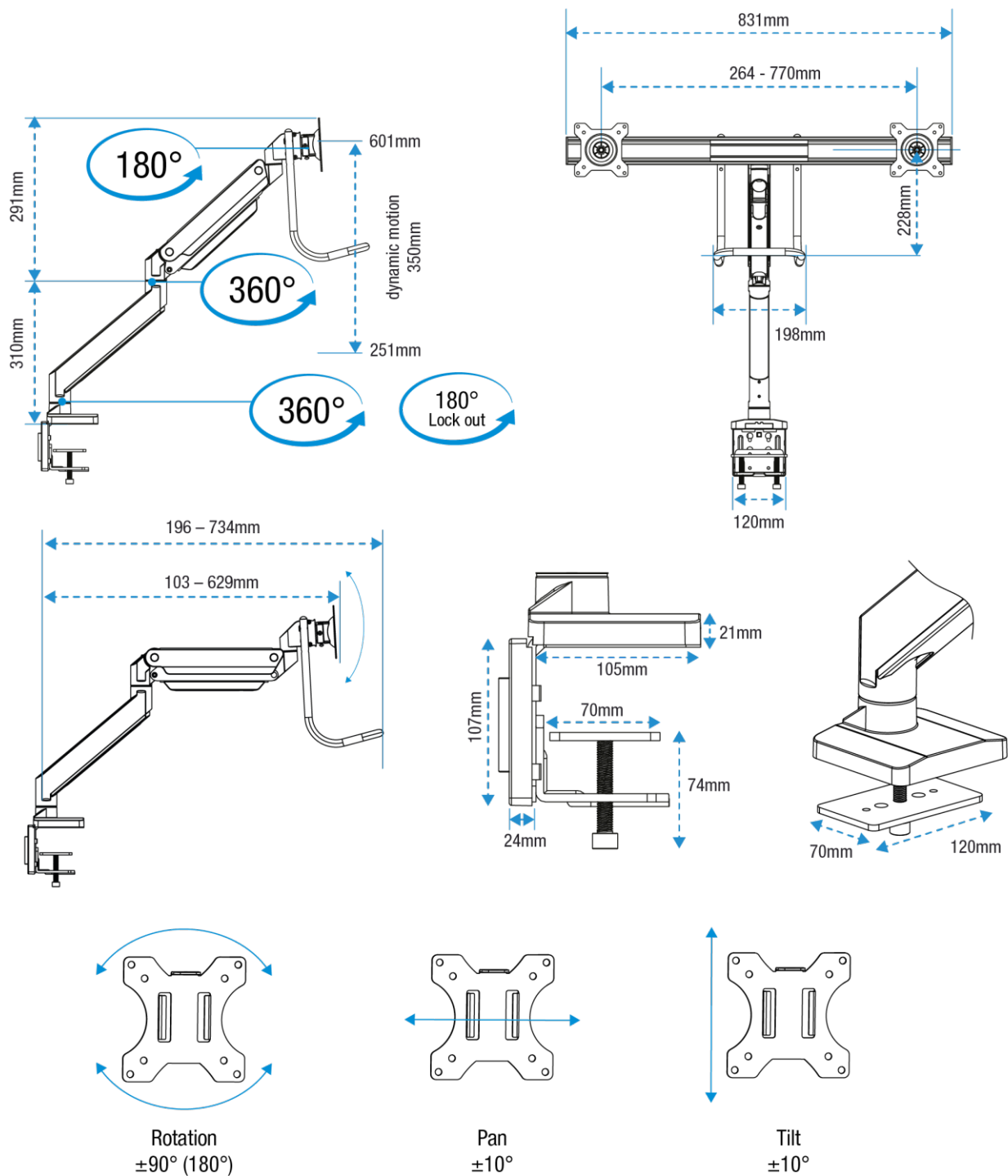
**Servicing:** Check joint parts regularly to make sure the screws have not loosened.
